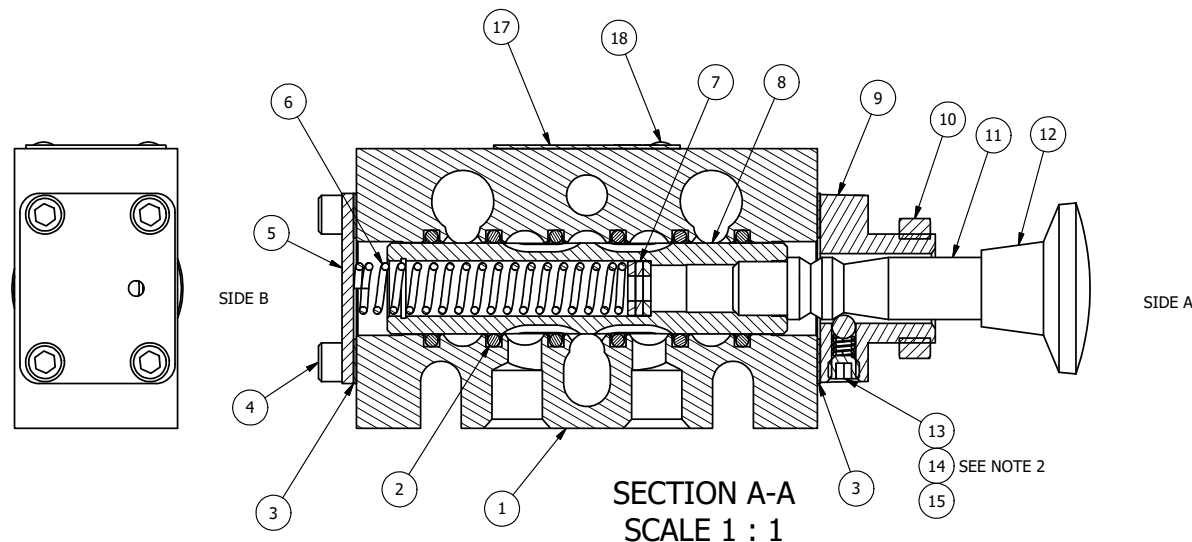
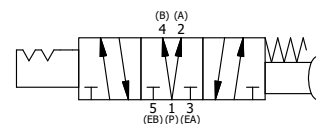


POSITION GASKET ON END OF VALVE
